§1

ATV GROUP® declares that it is part of ATV GROUP® CENTRUM FILMOWE ATV FILM® franchise,

§2

The purpose of the CAREER RECORD is to formulate the principles of mutual cooperation between the parties in terms of promoting the PARTICIPANT's image so that it can be used, or the participant can personally take part in: film and TV productions, commercials, reality shows, commercial photo sessions, promotional events, shows, castings, competitions and in other similar events organized by ATV GROUP® and other entities that are part of ATV Group® CENTRUM FILMOWE ATV FILM® franchise, or on behalf of other entities organizing such events.

§3

ATV GROUP®, acting in agreement and on behalf of the **PARTICIPANT**, will conduct promotional activities and disseminate the **PARTICIPANT's** image in order to attract entities interested in the use of the image or in personal participation of the **PARTICIPANT** in the ventures referred to in §2 of the career record. While conducting the activities referred to in §2 of the career record, **ATV GROUP®**:

- Promotes and disseminates the image of the **PARTICIPANT** by posting photographs in an electronic version with a description and the **PARTICIPANT's** code.
 - ATV GROUP®** shall select the photographs provided by the **PARTICIPANT** at its own discretion and shall upload the **PARTICIPANT's** image and description on the **FACE GALLERY** website in accordance with the regulations of the **CENTRUM FILMOWE ATV FILM® - FACE GALLERY** Chapter I
 - The **PARTICIPANT** consents to the free use of his/her image in promotional materials of **ATV GROUP® CENTRUM FILMOWE ATV FILM®** in all fields of use during the duration of the career record and after its expiration or termination, the aim of which is to enable the use of the image or the participant's personal participation in undertakings referred to in §2 of the **CAREER RECORD** issued by **ATVGROUP® CENTRUM FILMOWE ATV FILM®**;
- Conducts various promotional and advertising activities aimed at enabling the use of the **PARTICIPANT's** image or personal participation in the projects referred to in §2 of the **CAREER RECORD**.
- Conducts negotiations, on behalf of and with consent of the **PARTICIPANT** each time, with entities interested in using his/her image or in his/her personal participation in the undertakings referred to in §2 of the career record.
- Concludes, on behalf of and with consent of the **PARTICIPANT** each time, contracts with entities that will use the image of the **PARTICIPANT** or commission him to participate in the projects referred to in §2 of the **CAREER RECORD**. Remuneration for orders will be determined each time with the participant and specified in a separate agreement negotiated earlier with the ordering party.

§4

- In order to enable **ATV GROUP® CENTRUM FILMOWE ATV FILM®** to conduct the activities referred to in §3 of the **CAREER RECORD**, the **PARTICIPANT**:
1. Shall provide photographs in an electronic version free of charge with the author's agreement and consent to use and disseminate the mentioned photographs, presenting the image of the **PARTICIPANT** (with a description and personal data) to the representative of **ATV GROUP®** on the day of signing the **CAREER RECORD** or within 14 days at the latest.
The PARTICIPANT declares that: he/she has full copyrights to the electronic photographs taken by himself/herself or another business entity, and provided to ATV GROUP® for their use for implementation of the provisions of this CAREER RECORD. In the event of any claims against the ATV GROUP® CENTRUM FILMOWE ATV FILM® with regard to the publication of the photographs submitted by the PARTICIPANT, the PARTICIPANT shall assume all liability, including liability for any damages and other costs related to the claim incurred by ATV GROUP® CENTRUM FILMOWE ATV FILM®.
 2. The **PARTICIPANT** declares that:
 - a) he/she agrees to the processing of personal data on the basis of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC provided in the Personal Form for purposes related to the implementation of the provisions of the Career Record. In particular, he/she consents to the transfer of the data to entities operating as a franchise of ATV Group Centrum Filmowe ATV FILM®. The **PARTICIPANT** declares that he has read and acknowledged the information on the processing of personal data of the candidates for Face Gallery in the advertising, film and TV industry before concluding the Career Record.
 - b) he/she agrees to the processing of his/her personal data by the Administrator in order to receive the Newsletter and has read and acknowledged the information regarding the right to access his/her data to correct or modify it. He/she is aware that his/her consent may be revoked at any time, which will result in the removal of the email address from the subscription list of the Newsletter. - **Consent to receive the Newsletter**
 - c) He/she consents to the processing of his/her personal data regarding his/her state of health by the Administrator, for processing including profiling and disclosing it to third parties for the purposes of casting a given production. He/she acknowledges that he/she has the right to access the data in order to amend it and that his/her consent may be revoked at any time, which will result in the removal of the data from all catalogues kept by the Administrator. - **Consent to the processing of personal data, including profiling and information on the health condition**
 - d) He/she consents to profiling and disclosing his/her personal data to third parties for the purposes of casting a given production. He/she acknowledges that he/she has the right to access the data in order to amend it and that his/her consent may be revoked at any time, which will result in the removal of the data from all catalogues kept by the Administrator. - **Consent to transferring data to third parties**
 - e) **He/she has read and acknowledged the terms and conditions of CENTRUM FILMOWE ATV FILM® - FACE GALLERY®**
 3. The **PARTICIPANT** agrees to receive promotional, marketing and commercial materials sent by **ATV GROUP CENTRUM FILMOWE ATV FILM** by electronic means to the e-mail address provided during registration, as well as text messages to the telephone number indicated during registration in accordance with the Act on the provision of services by electronic means of 18 July 2002 (Journal of Laws 2002, No. 144, item 1204, as amended).
 4. The condition for the career record to be concluded is making a non-refundable payment of PLN 80.00 by the **PARTICIPANT** to **ATV GROUP © CENTRUM FILMOWE ATV FILM®** on the day of signing the **CAREER RECORD** and submitting photographs by the deadline referred to in §4 section 1.

§5

The **PARTICIPANT** can check current castings and orders posted in the **FACE GALLERY** and to add their own code according to the criteria listed in the briefing - included in **CURRENT CASTINGS**.

§6

In the event that **ATV GROUP® CENTRUM FILMOWE ATV FILM®** concludes on behalf of the **PARTICIPANT** a contract referred to in the career record §3 paragraph 4, both parties shall be bound by the following provisions:

1. **ATVGROUP® CENTRUM FILMOWE ATV FILM®** is obliged to:
 - a) notify the **PARTICIPANT** when he/she is selected in a direct or image casting about a proposal to conclude a contract by **ATVGROUP® CENTRUM FILMOWE ATV FILM®**.
 - b) explain to the **PARTICIPANT** all obligations resulting from the conclusion of the contract.
 - c) make all financial settlements, including the **PARTICIPANT's** remuneration after the completion of the contract in compliance with the provisions of the contract.
2. The **PARTICIPANT** is obliged to immediately notify **ATV GROUP® CENTRUM FILMOWE ATV FILM®** about all obstacles that prevent him/her from fulfilment of the contract.
3. The **PARTICIPANT** is required to enter **ATV GROUP®** as the ordering party on the casting card.

§7

Both parties concluding the career record declare that they both agree that **ATV GROUP® CENTRUM FILMOWE ATV FILM®** shall not be liable for any interruptions in the functioning of the **FACE GALLERY** catalogue beyond its control, as well as for personal artistic or media success that the **PARTICIPANT** can achieve, as it depends on personal traits of character, abilities and skills, as well as the demands of the advertising and media market,

§8

1. The **CAREER RECORD** is valid for a period of 12 months from the date of uploading photographs in the **FACE GALLERY**, not later than 1 month from the signing of the record.
2. The **CAREER CARD** is automatically extended for another 12 months according to the **FACE GALLERY** terms and conditions once the **PARTICIPANT** pays the fee in the amount referred to in paragraph 4(4) no later than on the last day that the career record is valid.
3. The **PARTICIPANT** declares that during the entire period of cooperation he/she agrees to the processing of his/her personal data. In particular, he/she consents to the transfer of the data to entities operating as a franchise of ATV Group Centrum Filmowe ATV FILM®.
4. The **PARTICIPANT** also declares that during the period of cooperation, he/she consents to the processing of his/her personal data in compliance with Regulation (EU) 2016/679 of the European Parliament and the Council of 27 April 2016 in accordance with paragraph 4 (2 and 3).

§9

1. Amendments to the provisions of the career record, as well as its termination or dissolution shall be null and void unless made in writing.
2. Any unregulated matters shall be governed by the provisions of the Civil Code, as well as other generally applicable laws.
3. If the Career Record is signed by a person who is not a legal guardian or legal representative in a fraudulent misrepresentation, misleading the ATV Group®, he/she shall be fully liable for it, and for any obligations arising from the signed Career Record. In such a case, ATV Group® shall be free from any liabilities arising from the Career Record.
4. THE **CAREER RECORD** has been made in two identical copies, one for each of the parties.
5. If there are two or more language versions of the Career Record, the Polish language version shall be binding.
